Budget -

Rep Sylvia - Delegation chose to have subcommittee done by exec committee – Rep Howard Chair of the Executive Committee to read a statement: The committee went line by and met with all dept heads and Commissioners – for a total of about 23.5 hours – 1.2million IDN money so it is not really a 2M – line transfer authority gives us a better understanding to know where the deficiencies are

The budget has increased 1.1m a year an average of 4.25% per year – it has outpaced the annual COLA

Rep Sylvia to explain IDN – Integrated Delivery Network – program established by Medicaid a waiver of SS rules – 5 year \$60m project – to build a network of providers in the state and sets up 7 regions in the state – the networks cross county lines -money is not controlled by any elective officials – they go to non-profits – demonstration project is in year 3 –establish a network of mental health and substance abuse disorder – in theory they are to be self-sufficient – they are in the progress of building it out – Community Health Services Network LLC - the County will be an associate member
